

#### THE BUSINESS MISSION CYCLE





The <u>EU Business Hub</u> is an EU-funded programme which supports EU companies active in **the green and low-carbon technologies, digital solutions,** and **healthcare and medical equipment** sectors to enter the two Asian markets by organising 10 business missions to **Japan** and 10 business missions to the **Republic of Korea** over the next four years. 50 EU SMEs and startups will be selected for each business mission. The objective of this programme is to **assist EU SMEs and start-ups in their expansion to these Asian countries.**

Healthcare and Medical Equipment Korea 2025, Healthcare - Seoul, 17 – 21 Mar 2025

#### **Green Assist – An outline**



 Advisory services to prepare green/greener investment projects in the EU



To build a pipeline of green investment projects



- On demand, free and customised
- By specialised experts or
- By consultancies specifically contracted for each request



- Available for private and public beneficiaries
- Diversified sectors: Circular Economy (across all sectors), biodiversity and natural capital restoration/preservation etc...
- Eligibility tests including "Best fit" and "no overlap"

#### Two forms of advisory services



#### **Project Advisory**

(by experts from a 'Roster')

Typically 20-80 expert days over 3-6 months

Project preparation, development or implementation (e.g. business plan (CAPEX, OPEX, revenues validation), financial structuring, environmental due diligence, cost-benefit analysis, review of business model,...)

Blending and combined use of funds

#### **Enabling Advisory**

(by consultancies)

Typically over 6-12 months

**Capacity building** 

**Market development** activities

Strengthening capacity for **investment-readiness** 

CINEA decides in between these 2 forms <u>mostly</u> driven by the question "Does the beneficiary (ies) has control over a specific investment project?" But room for flexibility (e.g multi-beneficiaries)

#### Enabling Advisory: key elements of the request from an Umbrella organisation



#### **RELEVANCE**

The support will bridge the gap to existing needs

#### **COORDINATION**

 The applicant is well suited to ensure effective liaison and follow-up with project developers.

## **COMMON CHALLENGES**

 The action addresses challenges common to all project developers (financial, regulatory, technical...)

## REPLICABILITY SCALABILITY

 The results of the support can be applied to other sectors or geographical areas facing similar challenges.

#### **DELIVERABLES**

 The scope of the action identifies deliverables that would bring most value to project developers (tools, platforms, KPIs...)

#### **Green Assist – synergies with Clusters**



#### 1. « Win-Win » situation:

#### 1. Green Assist:


- a. needs to deliver results on the ground
- b. requires visibility while marketing resources are scarce and hard to acquire room for delegation for « on the ground marketing»

#### 2. Clusters

- a. have a fiduciary duty to their members
- b. have a transversal approach & knowledge
- c. Have regular requests from member(s) hard to address room for delegation to external expertise (2: Enabling 3: project adv)
- 2. « Win-Win» conditions: recognition for all + understanding on key principles
  - a. Project and project owners genuine advisory needs only matters (rest is excluded)
  - b. Finding the right balance between «transversality» and «verticality»
    - Level of proximity to the ground of « ombrella organization/clusters»
    - Defining interface tasks & KPI ensuring expertise effectively filter through

#### **Enabling Advisory(\*): Who does what – illustrative standard case**





- 1. Requestor/Beneficiary \* engages with CINEA to define the Use Case and the relevant Work Programme (e.g. milestones, deliverables)
- 2. CINEA uses the Work Programme to collect bids from the 4 pre-selected FW contractors, through a simplified /competitive process. CINEA retains the best offer as per selection criteria defined by the framework contract and tasks stipulated in the request for services
- 3. The selected contractor delivers Enabling advisory services to the Beneficiary directly.
- 4. The Beneficiary disseminates (possibly with support from Contractors) the results to Project Owners identified in the Use Case, ensuring, on a best effort basis, maximum take-up by Users.

- > Integrate sustainability into your cluster strategy and keep an open dialogue with members
- Collaborate with other clusters to gain mutual benefits

#### What clusters can do to facilitate the green transition

#### Identify the sustainability needs and challenges of your cluster

It is important to take your members' needs as a starting point in the green transition. Shach out to your members via surveys and/or interviews and issen to any concerns and challenges they may have with becoming more sustainable - whether it concerns enargy efficiency, developing environmentally friendly products, adopting circular economy solutions, or something else. Ask them what their competences and prospects are and how you as a chaster can help them.

Some sectors might have come quite far due to logislation or other drivers, but others will need help to better understand the possibilities offered by the green transition. Similarly, some companies will be more positive toward the green transition than others. For reluctant companies, it might be visite to initially mainly focus on awareness raising and on providing information.

#### Facilitate experience sharing and mutual learning

The green transition presents new challenges, requiring an exploratory approach to knowledge-gathering and exchange. Both peer learning among similar companies and mutual understanding among different players, such as businesses, start-ups, research institutes etc., are essential for successful for succes

Clusters can contribute significantly to this by connecting different stakeholders and help strengthen mutual learning and colla boration in green transition areas of common interest. Actions can include:

- Organising networking actions and workshops
- Connecting different stakeholders such as SMEs and larger companies, or companies and research organisations.

The green transition can seem overwhelming - focus on the benefits it can bring to your members (efficiency, cost savings, simplification, innovation, new business opportunities, etc.), and adjust your communication to reflect potential benefits such as competitive advantage.

## Sustainability in Action Cross-border cooperation Green Transformation Cards Hackathon Sustainability Desk to help companies with their ESG strategies In 2021, the cluster Confindustria Emilia Area Centro set up a Sustainability Desk to assist their new companies with their ESG strategies

In 2021, the cluster Confindustria Emilia Area Centro set up a Sustainability Desk to assist their members on their sustainability journeys. The aim was to help member companies capture the full range of opportunities that comes from taking a strategic approach to sustainability – going beyond mere regulatory compliance.

As a first step, the cluster offered sustainability assessments in the form of a gap analysis to help companies create a sustainability strategy. One year later, they expanded the Sustainability Desk to include a Sustainability Orientation Service – a training programme structured in 2 modules of 3 hours each, adaptable in content and duration. The programme is available to both SMEs and large companies and can be extended to connected companies and/or suppliers. It is provided directly by the cluster staff of Confindustria



### Sustainability programme for graduates: a win-win initiative


- 10-month paid graduate program on sustainability management, innovation strategies, and the EU project funding landscape

## Support for SMEs developing Circular Economy and Sustainable solutions for the Agrifood sector in the Euroregion Pyrenees Mediterranean

- This initiative aims to support small and medium-sized enterprises (SMEs) in the agrifood sector to develop circular economy antions, promoting environmental sustainability and resource efficiency in the Euroregion Pyrenees Mediterranean.
- Activities within proposed projects may focus on:
  - Industrial water management: Treatment, recycling, and concerted use of water resources.
  - Sustainable packaging: Eco-design, plastic-free solutions, and new circular materials.
  - Process optimisation: Reduction of waste and adoption of circular processes.
  - Valorisation of co-products: Reuse and value creation from by-products.
- Proposals are expected to:
  - Accelerate adoption of sustainable and circular solutions in the agrifood sector.
  - Improve resource efficiency, reduce waste, and drive environmental innovation.
  - Strengthen interregional SME collaboration and competitiveness in the Euroregion.

## Integrated peri-urban areas in the transition towards climate neutrality

- This call focuses on developing and implementing strategies to **achieve climate neutrality in peri-urban areas**. It aims to integrate green and smart mobility, energy solutions, and sustainable land-use planning to reduce greenhouse gas emissions and enhance livability in these regions.
- Projects will demonstrate **scalable, innovative solutions** in real-life conditions across at least two domains, involving multiple urban and peri-urban areas. They must integrate **green and smart practices**, promote co-creation with stakeholders, and ensure measurable progress towards climate neutrality.
- Key objectives:
  - Mobility: Promote sustainable transport modes, reduce GHG emissions by 20%, and improve accessibility and connectivity.
  - **Energy:** Enhance decarbonised energy grids, support local energy communities, and develop renewable energy sources like solar and bioenergy.
  - Industry: Improve energy efficiency, deploy net-zero technologies, and increase recycling in industrial processes.
  - **Governance:** Strengthen policy integration, spatial planning, and stakeholder engagement for better land-use and resource management.

#### **Creative Innovation Lab**

- This call supports the **design and testing of innovative digital solutions** with potential positive long-term impacts across multiple cultural and creative sectors. It encourages **cross-sectoral collaboration** to address common challenges, including those related to sustainability and the green transition.
- The proposal shall address these focus areas:
  - **Environmental transition:** Promote greener practices in line with the European Green Deal and New European Bauhaus initiative.
  - **Content circulation:** Increase the visibility, availability, diversity, and audience reach of European audiovisual and cultural content.
  - Adaptation to new technologies: Leverage virtual worlds and AI to address opportunities and challenges in the sectors.
- Projects must focus on one or more of these topics:
  - Green practices: Support environmentally sustainable innovations in cultural and creative sectors.
  - Cross-sectoral collaboration: Promote cooperation between audiovisual and other CCSs, including partnerships with tech companies, start-ups, and business incubators.

#### Joint EUROCLUSTERS for Europe's recovery

- This call focuses on reinforcing innovation and adoption of new technologies for **strategic autonomy**. In particular, the emphasis is on **value chains** within or across one or more of the 14 industrial ecosystems identified in the European Industrial Strategy.
- The call is divided into two strands:
  - Strand 1 focuses on net-zero technologies and critical raw materials:
  - Strand 2 covers value chains not covered in Strand 1.
- Number of projects to be funded: 16 (with at least 8 projects for Strand 1)
- Maximum project duration: 36 months
- Budget: 42 million EUR
