


- These are the 19 KPIs (17 plus two candidates) of the 2024 ASMCR that try to provide a quantified picture of the nine competitiveness driver of the long-term competitiveness Communication and the 2024 ASMCR.
- While it is too early to establish stable trends for all the indicators, the report notes that 9 KPIs have improved, against 5 that have disimproved; 3 are stable, and 2 do not yet have new data. Notably:
 - •There are improvements in the area of the Single Market, private capital, renewable energy, SME's digitalisation and availability of ICT skills, as well as adult employment rate, the share of trade over GDP and the ease of regulatory compliance.
 - •There is stable performance In relation to public investment, patents applications and circular economy.
 - •And some worsening of the situation as to availability of venture capital, the share of R&D investment over GDP, energy prices, the level of skills reached by 15-year-olds in our education systems and the share of the EU exports over the rest of the world imports.
- Of course some of these KPIs may change in opposite directions fast from year to year (e.g. electricity prices), so wherever possible the report also takes into account longer trends.
- In fact, non-household electricity prices <u>have improved somewhat</u> since the publication of ASMCR. Prices have come down from 21 cts to 20 cts and from 20 cts to 19 cts (for resp. medium and large-sized users) per KWh from the first to the second half of 2023.
- These prices remain three times as high as those in the US no data for China (Japan similar to ours, UK much higher)

Accelerating uptake through open proposals for adavanced SME innovation

 - **Development of a mature technological** solution addressing EU security policy priorities in the areas addressed by the Cluster 3 work programme;
 - Facilitated access to civil security market for small innovators;
 - **Improved cooperation** between public buyers and small supply market actors for a swifter uptake of innovation in response to short to mid-term needs;
 - **Stronger partnerships** between small and medium EU security industry and technology actors to ensure the sustainability of the EU innovation capacity in the civil security domain and reduce technological dependencies from non-EU suppliers in critical security areas

Zero-pollution cities

- Projects are expected to contribute to the following outcome:
 - **Improved methods** for assessing pollution exposure (air, water, soil, noise) and their health impacts at the local/regional level;
 - **Better assessment of pollution exposure** for vulnerable groups, including those affected by socioeconomic factors, to inform more targeted health impact assessments;
 - Enhanced understanding of behavioral economics, psychology, and organizational behavior, to design **more effective measures** for reducing pollution in urban areas;
 - **Comparative analysis** of successful pollution reduction strategies at the local level, identifying key factors for success and potential replication in other areas
